### Fos Cavaou LNG Terminal – Capacity auction: July and August 2023

Fosmax LNG is marketing additional access capacities at the Fos Cavaou LNG terminal:

- 1 100 GWh on 23<sup>rd</sup> July 2023;
- 1 000 GWh on 31<sup>st</sup> July 2023;
- 1 100 GWh on 21<sup>st</sup> August 2023.

These capacities are proposed according to an ascending auction mechanism that will take place on the PRISMA platform, the subscription windows being scheduled on:

- 01<sup>st</sup> June 2023 for the Window of Arrival on 23<sup>rd</sup> July;
- 06<sup>th</sup> June 2023 for the Window of Arrival on 31<sup>st</sup> July;
- 27<sup>th</sup> June 2023 for the Window of Arrival on 21<sup>st</sup> August.
