<sup>1</sup> It is specified that, due to the technical specificities of the Terminal, the following provisions of the access contract do not apply to Fos Tonkin: Uniform Option (article 21.3), Inventory Extension Option (article 21.4), Weekly Send-Out Flexibility (article 23.4), Dedicated Storage Space (article 25).
